- Share GPC materials with other organizations



Distribute poison prevention materials

Ideas for distributing material:

- Ask healthcare providers to distribute literature and/or counsel their patients about poison prevention
- Ask pharmacists to place material in prescription bags
- Put up information on bulletin boards
- Create table tents for businesses



Ask retailers to donate child safety locks

Effective Presentation Tips:

- Know your audience
- Know your subject matter Involve your audience

- language
- Make it interesting
- Summarize

Unit 4: Reaching People with Limited Health Literacy

Health Literacy is defined as the degree to which individuals have the capacity to obtain, communicate, process and understand basic health information and services needed to make appropriate health decisions.

Unit 4: Reaching People with Limited Health Literacy

In order for a program to be effective, the audience must have access to information and must be able to understand what is being taught. Certain groups fall in the category of those with limited health literacy.

Those groups include:

- People with limited education
- People with limited English proficiency
- Minority population
- · Seniors/older adults

Targeted audience must be reminded that:


- Poison specialists can answer most medication questions
- All calls are confidential
- Translation services are available
- All calls are free

You should assume that in any audience that you are trying to reach, there are people with limited health literacy.

Unit 4: Reaching People with Limited Health Literacy

Barriers in utilizing the poison control center services:

- Lack of awareness
- Lack of confidence (shyness, shame)
- No telephone
- Fear/lack of trust
- Language barrier
- Cultural differences


The program should be designed to present key messages about poisonings.

- Identify poisons
- Prevent poisons
- Respond appropriately in a poison emergency

Children should be able to:

- Define a poison
- Describe a poison
- Identify common poisons
- Identify "caution" words
- Explain proper storage
- Describe when to take medicine
- Identify someone who give you medicine
- Explain ways medicine/vitamins can be poisonous
- Explain why plants and mushrooms shouldn't be eaten
- Describe how to respond in a poison emergency
- Identify the number to
